1970	Public Act 169, Local Historic District Act
1999	Amendment to PA 169 to Include a 25% Tax Credit
2001	Michigan's Historic Tax Credits Made "Permanent"
2007	SB 973 – Enhancements to Historic Tax Credits
2011	SB 566-568 and 644 – Michigan Community Revitalization Program
2016	Local Historic District Act Saved from Major Changes
