MHPN is pleased to honor two individuals at its 31st annual Fall Benefit! The Lifetime Achievement Award is presented by consensus of the Network's senior leadership to those who have worked throughout their careers to promote historic preservation in the State of Michigan.

Janet Brashler, Ph.D.
Professor and Curator Emerita, Grand Valley State University

A Leader in Michigan's Archaeological Community

Janet Brashler's dedication and contributions to Michigan archaeology over more than four decades cannot be overstated. Following work for the U.S. Forest Service in Michigan and West Virginia, Jan taught and conducted research at Grand Valley State University from 1990-2018, serving as a Professor and Curator of Anthropology. She is a respected expert on Precontact Native American ceramics and the rich cultural heritage of the Grand River watershed. Establishing good relationships between the archaeological and tribal communities is at the heart of her work. Jan has taught numerous field schools, has too many successful students to name, and has influenced many of her colleagues' research.

A Leader in the City of Niles and the Michigan Main Street Program

Always committed to public service, Lisa became the Niles Downtown Development Authority Manager in 2000. She recognized the importance of its historic buildings and, in 2001, successfully applied to the LISC National Main Street Program; in 2005, Lisa got Niles into the second cohort of the Michigan Main Street Program. Downtown Niles has benefited from Lisa's skilled and uninterrupted efforts. She joined other preservationists to have the downtown listed on the National Register in 2007. Lisa was an early advocate of the "green" and sustainable potential of historic buildings. As the longest serving Michigan Main Street Manager, her promotion of preservation as foundational to the program has been of inestimable value.



From the Cultural Advocacy Network of Michigan

On Wednesday, August 27, the Michigan House of Representatives passed a budget that **completely eliminates funding for arts and culture.** This devastating proposal would decimate Michigan's creative sector, threatening thousands of jobs, weakening local economies, and stripping communities of the programs and cultural resources they rely on.

The House budget is over \$5 billion smaller than the version passed by the Senate and includes dangerous cuts—phantom jobs and the **zeroing out of Michigan Arts and Culture Council (MACC) grants.**

If this budget moves forward, the impact will be catastrophic: Thousands of jobs lost across the state; economic instability for communities where arts and culture drive tourism, small businesses, and local investment; and loss of access to programs that support education, historic preservation, creative therapies, and cultural institutions statewide.

Why This Matters Now

The House, Senate, and Governor must agree on a budget before October 1 to avoid a government shutdown. Negotiations are happening right now, and this is our moment to act.

Take Action Today

We need every advocate to send a loud, clear message that cutting arts and culture is unacceptable. Here's what you can do:

Final call for 2026 conference abstracts!

The abstract submission deadline is 11:59 p.m. on Sunday, September 21. (NOTE: conference registration opens February 2026).

Fact sheet for Michigan House Bills 4503 and 4504 now available

House Bills 4503 and 4504 were enrolled in May, co-sponsored by Rep. Joey Andrews (D - 38th House District) and Rep. Steve Frisbie (R - 44th House District). The most significant proposal remains -- increasing the current \$5M annual credit cap to \$100M to better reflect the demand for the Michigan Historic Preservation Tax Credit. There are other proposed enhancements that will give more projects access to the credits.

<u>Visit MHPN's Advocacy page</u> for a new fact sheet you can send with your correspondence, provide your city council members, or hand to your legislators when meeting. Please don't hesitate to talk with your state legislators to let them know you support our House Bills. They expand the usefulness of the credits for both income-producing and residential properties in every part of the state.

Advanced Cemetery Preservation Workshop Glenwood Historical Cemetery and Arboretum, Flint, MI September 13, 9 a.m. to 3 p.m. \$95 per participant (includes all materials and safety gear) Register by September 5

MHPN invites you to an advanced, full-day training in cemetery preservation on the historic grounds of Glenwood Historical Cemetery and Arboretum in Flint. Designed for caretakers, advanced volunteers, and preservation professionals, this workshop offers in-depth instruction on the ethical, material, and technical aspects of gravestone conservation in Michigan.

Led by Dr. Thomas Henthorn, Suzy Ferguson, and Melanie Purkis, the workshop features a mix of expert presentations, live demonstrations, and supervised hands-on cleaning practice.

African American Cultural and Historical Museum of Washtenaw County Webinar September 18

This presentation explores the architectural, technical, and ethical considerations involved in the adaptive reuse of a residential structure built in 1824 for its new purpose as the home of the African American Cultural and Historical Museum of Washtenaw County (AACHM). The case study approach will highlight practical methods and real challenges encountered in transforming this significant early 19th-century home into a facility that not only preserves the past but also invites community engagement with African American history in the region.



Former Malcolm X residence receives historical marker

Aaron Sims, MHPN board member and co-founder and executive director of Project We Hope Dream and Believe, recently shared the news that the one-time residence of Malcolm X at 4336 Williams St. in Inkster, MI, has received a State Historical Marker.

In 2017, Project We Hope Dream and Believe acquired the residence, which belonged to Malcolm brother, Wilfred Little, also an official in the Detroit-born Nation of Islam's Temple No. 1. Malcolm lived in the home after serving several years in prison and granted parole by the Massachusetts State Parole Board. Malcolm arrived at the home, where Wilfred, his wife Ruth, and their children lived, on August 8,1952, and resided there into 1953.

Statewide SHPO survey for preservation practitioners

The State Historic Preservation Office (SHPO) is in the early stages of preparing the next Statewide Historic Preservation Plan, and they need your input. Please take a new survey which is targeted specifically towards historic preservation (and allied) professionals/volunteers who live and/or work in Michigan.

SHPO is interested in obtaining your ideas and vision for the future of historic preservation in Michigan. They also want to better understand who comprises the historic preservation workforce in the Great Lakes State as they consider current and future strategies to grow and enhance the profession. Some of this information has never been gathered before in a comprehensive format.

The results of the survey will inform the development of the next Statewide Historic Preservation Plan and will influence strategic direction for historic preservation over an eight-year period, from 2027-2034.

This survey is completely anonymous, has about twelve questions, and should take approximately five minutes to complete. Thank you!

Do you know a historic Black church seeking funding to strengthen its capital, staffing, and operations? To preserve and uplift these historic places and the neighborhoods they serve, the African American Cultural Heritage Action Fund established the Preserving Black Churches program, a \$60 million initiative backed by generous philanthropic support from Lilly Endowment Inc.

Preserving Black Churches grants ranging from \$50,000 to \$500,000 and are intended to preserve historic houses of worship (those with active congregations or that are being repurposed for new uses within the community) and advance preservation activities including capital projects, programming and interpretation, capacity building, project planning, and endowment and financial sustainability. Eligible applicants include churches, public agencies, and 501c3 non-profits.

The application portal is now open. Please review grant guidelines for additional details. Applications are due September 12, 2025.



Union City Society for Historic Preservation carriage house dedication

On September 27, at 1 p.m., the Union City Society for Historic Preservation will hold a dedication ceremony for their new Walsh & Engle Carriage House, built to house their rare 1870s doctor's buggy. The carriage house is on the grounds of the Hammond House at 210 Charlotte St., Union City, MI. This local group of preservationists has done an outstanding job of protecting the community's historical resources.
